

The regular meeting of Court Immaculate Conception #322 was called to order by Regent Karen Selensky on October 7, 2025, at the Cathedral of the Holy Spirit parish hall. Five officers were present. Twenty-seven members attended.

There were no guests present.

The Minutes were approved as presented. The Treasurer's Report was approved as presented and filed as shown. Regent Karen Selensky reported the following correspondence was received. Thank you from the Dalphina Mittlesteadt family and Assumption Abbey newsletter. She also reported that a picture of Elvira Rogstad and her daughter, Sharon Renfrow, was submitted to the SHARE magazine, since Elvira is our oldest member and hoped that members had noticed it.

Regent Selensky reminded everyone that the \$25 dues can be paid at any time now for the 2026 year.

Treasurer Mary Ann Morford submitted a bill from Maddie Abbot for the pizza for the JCDA Luau for a total of \$65.68. We need a motion to pay Maddie Abbott \$5.68 for the pizza at the JCDA Luau. Bev Rivinius made the motion to pay Maddie Abbott \$65.68 for the pizza provided for the JCDA September Luau, Sharon Wiederholt seconded, motion carried.

Old Business

JDCA Update—Regent Selensky reported that Maddie Abbott has done a stellar job starting up the JDCA with positive feedback from Father Hochhalter and Father Kovash.

Regent Selensky provided the following report in Maddie Abbott's absence: The JCDA Luau took place on Sunday, September 14, from 2-3 pm at the Cathedral parish hall. About 45 girls (ages 6-18 years old) were present; 20 girls paid the \$10 dues. Vice Regent Wolbaum, Kelly Fisher and Bev Rivinius volunteered to help. Service project included notes of encouragement for women at the Women's Care Center and bracelets for the St. Vincent de Paul Society to be delivered on Wednesday. October project is making prayer boards. A vote will decide where these will go, but some may go to the CDA homebound elderly ladies. We will meet with the older girls for potential officers. In November the installation of officers will take place. The Ascension Social Concerns Committee has generously offered to supply sashes. Maddie is grateful to Dorleen, Bev and Kelly for helping with dues and membership forms. Maddie will continue to give us updates.

Regent Karen Selensky reported that the Court received a \$100 check from the State Court to support our new JCDA Court. At the September meeting, Maddie Abbott and Regent Selensky were designated to sign checks. Since Maddie Abbott is unable to sign the checks per bank protocols, Regent Selensky asked for a motion that the three current officers (Regent Karen Selensky, Vice Regent Dorleen Wolbaum and Treasurer Mary Ann Morford) be assigned to sign the JCDA Court checks. Norma Rajme made the motion to approve the current officers assigned to the Court's checking account to sign all JCDA checks. Rita Mastel seconded. Motion carried. Virginia Dolajak suggested we ask the JCDA to join us for our next potluck.

New Business—Our Burrito Breakfast fundraiser will be October 12 being chaired by Celia Sattler. Fresh fruit in cups and Tang will be served along with two sizes of burritos – adult and youth. Celia pointed out there are three eggs, ham, peppers, onion and cheese in each burrito with a cost of about \$6. There will be a free will offering which will go in our general fund as we support 12-15 non-profit organizations throughout the year. Regent Selensky asked that all baked goods be priced in even dollar amounts with no cents. Regent Selensky will be purchasing the needed supplies for the breakfast.

Regent Karen Selensky shared that Johanna Nagel had a custom oak box made with packing material for the Blessed Mother statue. We are very grateful to Johanna Nagel as there was no cost to the Court.

Regent Selensky reported that the guest speaker for November is Nathan Gentry from Home on the Range. Items requested from Home on the Range this year are: NIV translated Bibles for youth, journals, sketchpads, colored pencils, and arts and craft materials. If you wish to donate any of these items, please bring them to the November meeting.
