

The regular meeting of Court Immaculate Conception #322 was called to order by Regent Karen Selensky on January 6, 2026 at the Cathedral of the Holy Spirit parish hall. Two officers were present. Twenty-four members attended. Father John Paul Gardner introduced the Klein family from Minot as prospective Junior Catholic Daughters members and led the rosary.

Laurie Swank was a guest and became a member.

Thank you letters from the Assumption Abbey and Lilian Seifert were passed around. Hands were raised when asked by Regent Selensky who had received the Share Magazine. Court Bishop Wehrle #1919 of Richardson is having their Festival of Tables Fundraiser which starts at noon mountain time on February 7, 2026 at St. Mary's Social Center with silent auction and door prizes. There was one correction to the Minutes, a name change – New Business: Lorie Seeger seconded to approve the 2026 budget.

Marella Krein asked the question of why we are using a small flag. Regent Selensky explained that the apparatus that John Berger built was too difficult to set up and the flag did not hang properly. We have limited storage space due to Fr. Ehli's request, so we decided to buy a smaller flag to use and store. The small flag cost \$32 with tax. There was a charge of \$20 to make a stand for the CDA banner and was listed as PVC on the report.

Marella Krein also asked about the memorial mass for Marge Schweitzer listed on the Treasurer's Report. Regent Selensky stated that the \$10 amount for memorial masses was added to the Standing Rules that were provided last month. Marella Krein stated that \$240.00 is given to Father John Paul Gardner every year for a mass to be said for all living members and all deceased members on a monthly basis. Regent Selensky stated they will remove that Standing Rule with the clarification that is also in the membership book. The Treasurer's Report was approved.

Regent Selensky stated that the \$25 membership dues could be paid to Treasurer Mary Ann Morford after the meeting.

Regent Selensky stated that Molly Freidel has been great to work with in updating the website.
